## JCrew Terms of Enrollment, Payment, and Closure Policies 2025-2026

### Payment Policies:

- To enroll and reserve a place for your child, the JCC requires one month's tuition per child as a non-refundable deposit.
- Deposits are then applied to that child's June tuition billing.
- Either a JCC Family Membership or \$200/child registration fee is required at the time of enrollment. JCC membership must remain current throughout enrollment in the program or the \$200 enrollment fee will be charged for the following month. If you choose to become a JCC member in the same calendar year of paying the \$200/child enrollment fee, the enrollment fee will be deducted from membership. See the JCC membership application for rates and more information.
- Cancellation on or before August 1, 2025: All JCrew fees paid will be refunded less \$50/child.
- Cancellation after August 1, 2025: No refunds of any JCrew fees will be provided including deposit and registration fee when applicable. There are no credits or makeup days offered due to illness, absence, suspension, emergency closing, Covid-19, vacations or acts of nature.
- Tuition is charged on the 20th of the month prior to service. For example, billing on September 20th is for October Tuition. Any schedule change that results in a reduction of days attended or withdrawal made after the billing date that month will not result in any credits or refunds. Tuition is based on total cost of the program from September through June and split into 10 equal installments regardless of the number of days JCrew is in session in any specific month.
- Tuition payments are charged monthly via EFT or credit card on file.
- If a payment is declined via EFT or credit card, there will be a \$30 charge.
- There is a 2.4% convenience charge for all credit card payments.
- The child's enrollment is subject to termination for non-payment of tuition.
- If a child is attending JCrew on any type of scholarship, no additional discounts apply.

## **JCrew Terms of Enrollment, Payment, and Closure Policies 2025-2026 continued.**

### **Closures:**

- The program follows the Bridgewater-Raritan School District Schedule and runs Monday – Friday 3pm-6pm. When Bridgewater is closed, JCrew is closed as well. Closure might be due to the pre-determined schedule such as vacations, holidays and teacher in service days. In addition, there may be unforeseen circumstances including weather emergencies, natural disasters, threats, Covid-19, or any other pandemic. Closures of JCREW could be mandated by the JCC Board of Directors, the Health Department, the Department of Children and Families, or the State or Federal Government.
- The JCC and the JCrew program follow all current policies and procedures including, but not limited to, any quarantine mandates for exposure and/or travel set forth by the NJ Department of Health and Department of Children and Families, our licensing agency.
- If, for any reason, an enrolled child needs to quarantine, there are no refunds.

### **Other Terms of Enrollment:**

- The JCC reserves the right to combine, change or cancel the program based on the minimum enrollment.
- Children will not be admitted to JCrew unless all forms have been completed and properly filled out by August 15, 2025. This includes the Universal Health Form and immunizations which must be updated annually at the child's well visit.
- JCrew aftercare closes at 6pm. If you are continuously late picking up your child, you will be charged \$5 for up to 10 minutes of lateness and \$1 for each additional minute.
- The JCC's student accident policy is in excess to your family insurance policy and any other collectible insurance.
- We have the right to suspend any adult or child who we deem unsafe to the program, is continually disruptive, or for whom our staff is unable to meet their needs. No refunds or credits will be issued.
- The JCC reserves the right to change/adjust this form and terms of enrollment, payment and closure policies.
- JCrew may photograph and video my child and use these images for brochures, social media, websites, promotional, and/or advertising purposes (no names will be used without prior permission).
